I'm going to advocate that Legislation MANDATE that we give our children the same QUALITY EDUCATION that they do the Suburbs and the surrounding counties!

B. Education

1. How do you feel about the role of charter schools in Pennsylvania's educational mix? If dissatisfied, what changes in State law would you sponsor to fix the problem?

I'm going to advocate that **Legislation MANDATE** that we give our children the **SAME QUALITY EDUCATION** that they do the Suburbs and the surrounding counties!

Every child should have a right to a quality education. Likewise, parents have a right to enroll their children in a Public School, Private, Catholic, or Charter Schools etc. However, Commonwealth have a right to make sure that the children attending Public Schools are fully funded, the children are given a Quality Education,

opportunities, and resources that will enable the children to thrive, help them to become academically inclined across all subjects, prepared, trained, and ready to go straight into the workforce. This approach will help the Public School children given that they decide that they do not want to go to college and/or a trade school or do not get accept into the programs of choice.

In brief, Pennsylvania's Public Schools fund should have a separate budget from the other avenues of education. We should allocate funds to the other means of education as well. However, we must make sure that our Public Schools are fully funded first! Also, we must make salaries more attractive to teachers in the Philadelphia County, to foster teacher retention and motivation to stay committed to providing a Quality Education to the students attending the School District of Philadelphia; also, we must make salaries attractive to Black Men. This is imperative for the Urban Communities and its children. Children in the Urban Communities respond better when they work with people who can identify with them and no the issues that they are plaqued with, prior to and after their school hours. Black Men can help restore structure in our schools and within our communities while working as educators and working with our students.

2. What factors do you believe should be considered in determining overall levels of school funding in the Commonwealth, and funding per school district?

Commonwealth should make every effort to assist with funding the various means of education, to allow our children and parents to have a choice of what type of school our children will attend and acquire knowledge from. However, we should strongly consider the needs of the students based on their performances academically,

economically, socially, and mentally. This requires a holistic approach. Unlike Private, Catholic, and Charter School children, it is a proven fact, those children in the Urban and impoverished communities perform poorly as a result of other adverse issues before and after school. This is largely due to their parents and grandparents not acquiring a Quality Education from the Public School System which resulted into them earning less wages, working two (2) and three (3) jobs to make ends meet (STILL NOT ENOUGH), not being able to assist with homework because they have to be at work, unemployed and part-time employed parents, the system removing the rights of parents to discipline their children the best way they know how (it worked for my brothers; they are respectful men today), mass and wrongful incarceration of the Black men, family health, alcoholic, and drug addictions, and mental health issues (Stemmed from Life's Frustrations), etc.

3. Do you believe public college, or community college, should be tuition free?

An investment in our children is an investment towards our future!

Absolutely!!! I would have been a doctor or an attorney had public and state colleges been free. I had the drive, determination, motivation, and desire to pursue a career possessing a dual doctorate and law degree. Unfortunately, that dream was halted because I did not have the money to attend and pay all fees for education, room & board, travel, and food expenses. It is okay though because I was able to happily be a public servant to the people who needed me most.

4. What role do you believe standardized tests should play in evaluating teachers, schools and students, if any?

A standardize test should be utilized to identity the subjects that students require remediation and school funding. Often, standardized test reflects students' academic performance level or lack thereof. This gives Law Makers and the School Board insight on what areas and how much funding should be allocated to each school, to make sure that every child receives a Quality Education and what he/she needs to academically thrive.

Please note that there are other adverse issues that need to be examined and addressed to accompany how we utilize standardized test and the allocation of funds to the various schools across the School Districts.

C. Budget and Taxes

1. Do you support a Constitutional Amendment to permit progressive taxation in PA, in whole or part?

Yes, I do support the Constitutional Amendment to permit

Progressive taxation in PA. However, I support lowering the tax brackets as well. I do not agree with workers having to pay nearly half (37%) of their earnings in taxes.

In many cases, people receiving unearned income solely rely on the benefits. Moreover, the benefits are only a fraction what is needed to survive with today's inflations, re-gentrification displacements, and increase in COLA- Cost of Living Allowance.

3. What changes if any would you support in corporate net income tax levels?

Corporations' income tax need to increase. This would

revenue into our communities. Corporations' tax percentage should not be lower than individual tax payers.

4. What changes, if any, would you support in the personal income tax?

I would support lowering the tax bracket for individuals.

H. Criminal Justice

1. Should stop and frisk be limited or outlawed?

Stop and frisk directly targets our Black Men and has shown to be detrimental to our Black and Brown families and communities, which has also negatively impacted both the rich and the poor in all communities.

2. How would you deal with the problem of mass incarceration of minorities, particularly minority youth?

I would first assess case by case to see if the charges are warranted, accurate, and fair. Then, I would assess whether the placement is the correct placement. Many people are placed in prison when they should actually be stipulated to a mental institution to be treated for a mental instability (ies). Likewise, there are some people imprisoned when in fact they need to be stipulated to complete a drug treatment program.

3. Should marijuana be legalized for recreational use?

I do not have a preference on it being legalized or not. However, I would not object if Legislation wanted to pass marijuana for recreational usage.

J. Labor

1. Would you support legislation to strengthen protection for workers trying to form or join a union?

2. Should the minimum wage be increased? If so, to what level and should the increase be indexed to inflation?

The aforementioned wage increase speaks to only Philadelphia. I would have to assess the COLA and wage

impacts in other counties of Pennsylvania before I make an informed and sound decision for other counties.

3. Do you believe that Philadelphia and other municipalities should continue to be pre-empted from increasing the minimum wage on their own?

Philadelphia should be able to increase the minimum wage for Philadelphia.

4. Do you support privatization of retail liquor sales in Pennsylvania? Are there any other services that you believe should be considered for privatization?

I WILL NEVER SUPPORT PRIVITIZATION OF ANYTHING THAT BELONGS TO PENNSYLVANIA!!!

Pennsylvania has well and highly qualified professional and experts that that run our liquor industry. If not, we can create them.

K. Transportation

Currently the State constitution mandates that revenue from the State gasoline tax be spent only on roads and bridges. Would you support an amendment to the Constitution allowing gas tax revenue to be spent on public transportation?

I would support an amended law for the State Constitution allowing gas tax revenue to spent on public transportation if it states that the roads, bridges, and infrastructure is fixed first with the money. I'm open, but I have to see how it would work. I do not want to take monies away from one entity if it still needs it to share with another entity.

Further, I would have to review the existing law (s), data of what is already in place, the current benefits, future pros and cons, and so on before making a sound and informed decision.

L. Reforming Legislative Districts

1. Do you support measures that would (a) form an independent commission, and (b) apply sound methodologies, to draw all congressional, State House, and Senate districts fairly in Pennsylvania?

or not support an independent commission on the various district levels. I would need more information to make a sound decision or render my support. For example,

- 2. Would you support the reduction in size of the current PA House from 203 seats to 151 seats, or some other number?
