II. Income and Wealth Inequality, and Benefit Programs.

- 1) What is your position on the rate of the estate tax, and to whom it should apply? I would have to study this further small farmers and middle and working class families should not be penalized. I see this more for the millionaire and billionaire class. I would also like to protect assets for working and middle class families from the 100% tax that is Medicaid. Families are wiped out financially when a loved one needs long term care.
- 2) How, if at all, should the personal income tax be modified? Yes lower for middle and working class and much higher for people earning more than \$300,000 / year
- 3) Would you impose a tax on stock and bond transactions? If so, at what rate? Yes but I am unsure at what rate.

High Speed Rail funding for Pennsylvania and replacing the current public transportation buses and public vehicles with Hydrogen powered and electric powered vehicles.

Convert old coal mines to geothermal systems currently utilized in the Netherlands

- Banning new nuclear plants and enacting plans for the ultimate shutdown of existing ones? No. I would like to see Navajo lands remediated from nuclear dust caused by mining and water pipelines to Native American Lands suffering due to lack of water but used for mining – nuclear, cooper, lithium, iron etc. I would like to see the The General Mining Law of 1872 updated to include protections to Native American religious lands, remediation of those lands, sharing in the gross profits of any extracted minerals and requiring their consent when mining is on their ancestral lands.
- Infrastructure support (recharging stations, etc) and tax incentives for electric automobiles? Yes and No I have deep concerns about the anti-union and anti-workers rights and safety currently exhibited by Tesla and others. No one gets a blank check. I support environmental renewal and stewardship alternative energies are not clean when you include the extensive amount of mining involved especially on indigenous lands here and around the world and Africa. THe same players who brought us war and environmental catastrophes control many of the mineral rights around the world.

Yes and demand that schools return their focus on educating students and not college sports and very expensive dorms. Also the tax code could be used that would allow the cost of college tuition to be deducted from a student's or their parent's taxes.

 How, if at all, do you think U.S. trade policy needs to change? Yes - we need to penalize companies that ship manufacturing to cheap labor countries. We need to provide tax incentives to those that manufacture in the U. We need to declare more goods (semi-conductors, masks, surgical gloves, computers, drugs) as

- national security items that must be manufactured in the US. I would vote YES on Build Back Better which focuses on US Trade policy and manufacturing in the US.
- 2) What measures would you support to reduce youth unemployment, particularly among minorities? I believe we need to institute job training programs in high school as well as fund and promote entrepreneurship in hight
- 3) How would you reform or repair Social Security? I would provide raises to seniors who earn less than \$100,000. I would eliminate Medicare deductibles and copays, negotiate prescription drug costs, add dental, eye care and hearing aids to Medicare.
- 4) How would you prioritize the elements of the President's Build Back Better Plan, and would you vote to pass those elements without the rest? I believe we need to pass the entire bill but I also know that if we put the Medicare items first that would put Manchin, Sinema and the Republicans in a corne. We need just job transitions if we are going to move into the next generation of energy which currently does not exist.
