#### I. OVERALL

What would be your three highest priorities as a legislator? Explain.

- 1. Working to end discrimination in schools and the workplace
- 2. Work to Invest \$30 million in anti-violence programs
- 3. Expand paid leave and raise the minimum wage for hardworking Pennsylvanians These three legislative priorities will make my district and our state a safer, and more equitable commonwealth for all.

#### II. Education

- 1) Do you believe public college, or community college, should be tuition free? yes
- 2) What role do you believe standardized tests should play in evaluating teachers, schools and students, if any?
  - a. Yes. While standardized test are not the only indicators of student achievement, there is a value in marking this objective progress.
- 3) What factors do you believe should be considered in determining *overall* levels of school funding in the Commonwealth, and funding *per school* district?
  - a. Across the Commonwealth and per district, funding should able to meet the need of the district size and scale. State funding should support where poorer districts are not able to provide adequate funding through other funding levers.
- 4) Approximately 33% of Philadelphia students are enrolled in charter schools. What is your position on the expansion of charter schools? Should they be given public money via vouchers or similar programs (like ESAs)? What role do you think public schools play in our city?
  - a. I am not in favor of expanding the existing charter schools within Philadelphia. I am opposed to voucher programs. Public schools

should be pillars within our community and should be properly funded to meet the needs of their students and help them to succeed in life.

## III. Budget and Taxes

- 1) Do you support a Constitutional Amendment to permit progressive taxation in PA, in whole or part?
  - a. Yes

  - a. We should raise corporate net income tax to levels that close state budget gaps and mandates corporations pay their fair share.
- 3) What changes, if any, would you support in the personal income tax?
  - a. Equitable tax increases on top wealth earners across the state.
- 4) Do you support the <u>Fair Share Tax Plan</u> proposed by the PA Budget and Policy Center, with its emphasis on raising the tax rate on unearned income? Yes, I am the source of this legislation, having first introduced it to the PA statehouse.
- 5) Do you support full elimination of the Delaware loophole? Yes
- 6) Do you support a tax on fracking, and at what level? Yes, around 7% like states like Texas.
- 7) Do you support the Keystone Opportunity Zone program? Would you introduce legislation to eliminate it, or to limit the number of times a parcel's KOZ designation can be renewed or extended? More generally, do you support tax breaks to lure or retain businesses?
  - a. Yes, I support it but would be open to limit the number of times a parcel's KOZ designation can be renewed to ensure no party is taking advantage of the system

## IV. Public Banking

## V. Women's Rights

- 1) Do you believe there should be any restrictions on a woman's right to choose? If so, what? No
- 2) What additional protections should be enacted into law to protect women's health care in light of the pending decision by the U.S. Supreme Court to override or sharply curtail Roe v. Wade?
  - a. The PA State Constitution should unequivocally protect women's right to choose
- 3) Would you support proposals to ensure that women and men working in the Commonwealth receive equal pay for equal work? Yes

#### VI. Children and Families

- Should the state require businesses to provide paid family leave? Generally, yes, but some small businesses might deserve some level of consideration
- 2) Should the state provide universal availability of affordable childcare? If yes, how would you achieve this? Yes, through a fair education funding formula enacted across the state.

#### VII. Environment

- 1) Do you support a ban on fracking in whole or part? Explain.
  - a. No. We have to frack safely but at this time I do not support the ban.
- 2) Would you support banning the use of single-use plastic bags? Yes
- 3) Do you think Philadelphia should be compelled or induced to sell PGW? No
- 4) What measures would you support to move PA off its reliance on fossil fuels and expand use of renewable energy sources?
  - I would support investments in renewable energy, and incentives for renewable energy companies and startups, as well as incentivize electric cars for producers

- and consumers. I am the sponsor of legislations to promote renewable energy, and a big supporter of RGGI.
- 5) What criteria would you use in making appointments to the P.U.C.?
  - a. Experience in consumer advocacy, and a commitment to protecting the consumer over corporations would be my primary criteria.
- 6) What steps would you take to ensure environmental justice in the placement and remediation of structures that pollute?
  - a. The state legislature, governor's office, and PUC (to the extent they can) should protect residential areas from harmful pollutions, regardless of the income levels of that community.
- 7) What, if any, other measures would you support to preserve or improve our environment? (water issues, park preservation, detoxification of school buildings, etc.)
  - a. Strengthened audits of public schools to ensure our students can work in a safe and healthy learning environment, specifically removing lead, mold, and asbestos. I support the carbon Tax. I believe that climate change is one of the top four issues our nation must address.

## **VIII. Criminal Justice**

- 1) Should stop and frisk be limited or outlawed? Yes, outlawed.
- 2) How would you deal with the problem of mass incarceration of minorities, particularly minority youth?
  - a. First, we are working to better mentor of youth, but furthermore, we should reinvest in education grants for the incarnated, and invest in programs to help with job training and readiness for persons leaving the criminal justice system so that they do not end up back in it. Of course, we must also ensure our public schools are better funded so they can operate as pipelines to access and opportunity for the youth.
- 3) Should marijuana be fully legalized? Yes, legalized and regulated.
- 4) Should privately-owned prisons be permitted in Pennsylvania? No

- 5) Should we ban the box in Pennsylvania? Yes
- 6) Should PA continue to build new prisons? No
- 7) Should PA begin to close prisons? Explain. Yes, we should work to purchase and operate or close down private prisons.
- 8) Do you support an end to the death penalty? Yes
- 9) When if ever, should a juvenile be tried as an adult? Never
- 10) As a general matter, what do you think the state can do to reduce the murder rate in Philadelphia, while maintaining respect for civil liberties and the overall need for decarceration of our city?
  - The state can provide more mental health resources and services to at risk community and individuals. The state police should be made available to support Phila. police dept.
