d. How do you plan to win?

I have a large team of supporters from across the state working to help meet our fundraising goals and spread our message. While we are of course hyper-focused on a local level with our voters, we are also forging strong alliances with progressive organizers and politicians across the Commonwealth who believe in our cause. We are in the process of building a self-sustaining fundraising machine and are in touch with a coms and media team we plan to hire. We have just hired a professional fundraiser who previously fundraised for the Summer Lee campaign and are very optimistic. We are confident our new coms person, along with our fundraiser and strategically place meet-and-greets, fundraisers, and candidate events will get me the exposure, funding, and positive press coverage I need to succeed.

e. How much money have you raised? Prior to hiring our fundraiser we raised about 2500. Our campaign launched in December. How much do you expect to raise? We expect to raise 100k or over.

- 3. What three things would you most want to accomplish if elected?
  - 1. Institute the biggest investment and expansion in public transit in over 100 years by demanding Harrisburg and Washington fund our transit infrastructure properly so we cab build the Roosevelt Blvd Subway, the Germantown Ave Subway, finish the Arch Street Subway, build subway stations in Center City between 15<sup>th</sup> Street and 30<sup>th</sup> Street, and expand SEPTA commuter bus service into NJ to reduce traffic congestion on our streets.
  - 2. **City-wide Universal Healthcare.** Many times people fall into this weird situation where they have too much of an income to qualify for Medicaid, but too little money to afford private insurance coverage. I am proposing the creation of a city-wide insurance program that people in this situation can apply for and will provide no-cost treatment at any medial facility within the city of Philadelphia's boundaries. As another initiative within this program, I will increase the number of city-owned and run medical facilities providing essential medical services such as general practitioners, behavioral health, pediatricians, OBGYN, reproductive health, family planning, urgent care, geriatrics, and LGBTQ+ services.
  - 3.Improved Essential City Services & Better Constituent Services. It shouldn't take months (if they ever come at all!) to get a pothole filled. You should be able to access the alleyways behind rowhomes. It shouldn't take an hour and a half to get through to 311. Workers at a municipal office should be able to answer your questions in a correct and timely fashion. These are basic concepts that we expect from any municipal government, anywhere. Philadelphia should be no different. I also am a firm believer that the Public should have better access to their elected officials. I will pass legislation allowing for the creation of district and local constituent service offices for both City Council and the Mayor's office so those who are unable to go all the way to Center City have better access to constituent services and city programs.

#### III. ISSUES

# A. Economic Development

What do you see as the current economic picture of Philadelphia and what would you do to make economic development more just, fair, and equitable for all Philadelphians?

Would you back legislation to:

1. Impose an impact fee on businesses failing to pay workers \$15/hr to reimburse the City for the costs of relieving poverty?

We also need to develop rental subsidy programs for those that wish to stay in the same apartments or rented homes if they have been there long-term.
